NOTICE OF GENERAL MEETING

Notice is hereby given that a General Meeting of Members of Spinal Life Australia Limited (ACN: 167 906 256) (the Company) is to be held on:

BUSINESS:

1. Welcome and Meeting Open

2. Amendments to the Constitution

To consider and, if thought fit, to pass the following resolution as a special resolution:

That the Constitution of Spinal Life Australia Limited be amended with effect from the conclusion of the General Meeting by:

- 1. Deleting the existing Clause 3.1(2) and inserting new clause 3.1(2) as follows:
- " to co-ordinate and deliver opportunities to assist people with a disability to participate in sport, recreation and leisure opportunities to improve their health, wellbeing and social connections and to design and deliver best practice values-based services which address their needs and are member-driven;"
- 2. Deleting the existing Clause 3.1(4) and inserting new clause 3.1(4) as follows:
- "to foster beneficial partnerships that develop the capacity of communities to meet the needs of people with a disability;"
- 3. Deleting the existing Clause 3.1(5) and inserting new clause 3.1(5) as follows:

"to develop and facilitate processes that encourage people with a disability to network and support their peers;"

Note: For this resolution to be passed, at least 75% of the votes cast by members entitled to vote (either in person or by proxy) must be in favour of the resolution.



3. **Close of Meeting**

VOTING

Only **Ordinary Members** are eligible to vote. Employees of the Company are ineligible to vote but may attend and be heard at the meeting.

PROXIES

Ordinary Members may appoint a proxy to vote on their behalf at the General Meeting by completing and signing a Proxy Form, which will be issued separately.

EXPLANATORY NOTES

1. Amendments to the Constitution

Members will consider and, if thought fit, approve a Special Resolution for the Constitution to be amended in accordance with the requirements of section 136 of the *Corporations Act 2001* (Cth).

A Special Resolution of the members voting in favour of the resolution is required in order for the Special Resolution to be approved. This requires at least 75% of the votes cast by the members at the meeting (voting either in person or by proxy) to be cast in favour of the Special Resolution.

BACKGROUND ON AMENDMENTS

The proposed changes, and the purpose of the changes, are summarised below. A consolidated version of the Constitution incorporating the amendments in marked-up form is available at https://www.spinal.com.au/gmJune2024.

If the Special Resolution is approved, the changes in that document will be accepted and the document will become the Constitution on and from the date the Special Resolution is approved in accordance with section 137 of the *Corporations Act 2001* (Cth).

RATIONALE

In early 2024, the members of Sporting Wheelies and Disabled Sport and Recreation Association Queensland (Sporting Wheelies) voted to transition the operations of their organisation to Spinal Life Australia.

Since this decision, the management of the operations of Sporting Wheelies has transitioned to Spinal Life Australia, including an appointment of a new Chief Operating Officer and alignment of processes, systems and policies.

Sporting Wheelies continues to operate as Sporting Wheelies, at the same location – albeit now as a department of Spinal Life Australia.

Sporting Wheelies has traditionally received grants from the Queensland State Government and the Commonwealth Government to fund the development and delivery of sport and recreation activities for people with disability.

Discussions with the Queensland Government, particularly the Department of Tourism, Sport and Innovation (DTIS) have indicated that in order to remain eligible to apply for and receive grants from that Department, the Constitution of Spinal Life Australia needs to reflect an Object relating to "sport and recreational pursuits".

With this in mind the Board of Spinal Life Australia obtained legal advice on proposed alternative wording to reflect "Sport and recreation" in the Objects of the Constitution of the organisation.



In accordance with the Constitution of Spinal Life Australia, members are required to be informed of and vote on any proposed amendments to the Constitution.

The proposed minor amendments to the Constitution are focused on ensuring our ongoing eligibility for grants from the Queensland State Government, and Commonwealth Government leading to better financial sustainability of services and activities offered through Sporting Wheelies. Two minor changes are also suggested to reflect the diverse audience of people with disability who will benefit from Sporting Wheelies programs – even if they are not yet members of Spinal Life Australia.

As a result, it is proposed that changes be made to the Constitution in relation to the "Objects" of the organisation contained therein.

The key changes included in the Constitution are set out in the table below.

Objects 3.1 (4)	Replacement of the term "members" with the term "people with disability" in Object 4:
	Existing "to foster beneficial partnerships that develop the capacity of communities to meet the needs of members and other people with a disability;"
	Recommended change "to foster beneficial partnerships that develop the capacity of communities to meet the needs of people with a disability;"



Objects 3.1 (5)	Replacement of the term "members" with the term "people with disability" in Object 5:
	Existing " to develop and facilitate processes that encourage members to network and support their peers;"
	Recommended change "to develop and facilitate processes that encourage people with a disability to network and support their peers;"

Members are asked to vote on these proposed amendments to the Constitution.

CONCLUSION

The directors believe that the proposed amendments to the Constitution will ensure the organisation is able to apply for grants from the widest possible source of funding bodies.

The directors unanimously recommend that members vote **in favour** of the resolution to adopt the amendments to the Constitution.

Voting

Ordinary Members are eligible to vote. Employees of the organisation are ineligible to vote but may attend and be heard at the meeting.

The resolution to amend the Constitution will be subject to a poll of members. The results of the poll will be announced at https://www.spinal.com.au/gmJune2024. following the meeting.

Members can vote in the following ways:

- Appointment of a proxy: If you are entitled to attend the General Meeting of Members and vote, you may appoint an individual or a body corporate as a proxy. A proxy does not have to be a member of the organisation. If you appoint a proxy, you may either direct your proxy how to vote or give your proxy discretion to vote as they see fit. If you appoint the Chair of the meeting as your proxy, and you do not direct your proxy on how to vote the resolutions, then by submitting the proxy appointment you will be expressly authorising the Chair to exercise your proxy on the resolutions.
- **Voting in person:** Members participating in the meeting online will be able to vote directly at the appropriate time in accordance with any instructions of the meeting host. This will take place using a computer, smartphone or tablet device via the online platform.
